Do you know what the MTNA Foundation is? Have you heard of an MTNA Foundation Fellow?





### 2014 WMTA Conference October 24-25, 2014

Holiday Inn & Conference Center Stevens Point, Wisconsin

#### Registration is now open!

The 2014 annual conference "Music's Past~Music's Future" for the Wisconsin Music Teachers Association will take place the weekend of **October 24-25** at the Holiday Inn Hotel & Conference Center, 1001 Amber Avenue in Stevens Point. It is directly off highway 10 and accessible to I-39. Overnight room rates are \$70.00 (double occupancy) and includes free Wi-Fi, fitness center, and indoor pool facilities. That is the lowest rate WMTA has had in several years. We also have an affordable exhibitor rate, with the hall placement directly in the middle of the large Expo room. This year's conference is JAM PACKED with activities and breakout sessions! There's a wide variety of topics that will energize your teaching. In addition, we're hosting a judging workshop, so for those members and non-members who may be interested in supplementing their income by judging for WMTA, be sure to attend the Friday workshop. Included in your registration are two recitals and the premier of the WMTA Commissioned Composer's work! Friday evening banquet and awards ceremony will also have entertainment provided by the Aber Suzuki Center students.

We will have TWO student master classes included in this year's conference—one will be a composition master class conducted by Chris Goldston. Conference guest artist will be Dr. Tammie Walker, Professor of Piano at Western Illinois University, received the B.M. degree in Piano Performance, *summa cum laude*, from the University of Wisconsin at Eau Claire, where she studied with Penelope Cecchini, and the M.M. and D.M.A. degrees in Piano Performance and Literature from the University of Illinois at Urbana-Champaign, where she studied with Ian Hobson and was a winner of the University of Illinois Concerto Competition. An active solo and collaborative pianist, Dr. Walker has concertized throughout the continental U.S., Hawaii, and western Europe, having given over 300 performances since her hire at WIU. Recent performance highlights include solo recitals and lecture-recitals in Pennsylvania, Indiana, Georgia and West Virginia and concerto performances of Shostakovich *Concerto No. 1*, Grieg *Concerto* and Rachmaninoff *Rhapsody on a Theme of Paganini*. She is currently preparing for a recital and master class tour in Seoul, South Korea in November, 2014.

#### **CONFERENCE PREVIEW**

- 1. IMTF Session, Bonnie Blanchard "Earn What Your Worth" and
- "Transform Your Teaching". Bonnie Blanchard is a nationally certified teacher of music from University of Washington. She has taught flute for over thirty years. Bonnie is the author of the Music for Life series, Making Music and Enriching Lives: A Guide for All Music Teachers and Making Music and Having a Blast! A Guide for All Music Students, published by Indiana University Press.
- 2. Dr. Martha Thomas, "Forgotten Romantic: Max Reger's Intermediate Pi-

ano Repertoire". Dr. Martha Thomas, has been on the piano faculty of the University of Georgia School of Music since 1986. A native Texan, she holds degrees through the doctorate in piano performance from the Universities of Texas and Wisconsin. Her major piano professors include William Race, Danielle Martin, and Howard Karp. Dr. Thomas has appeared in master classes with nationally renowned pianists Leon Fleisher, John Perry, and Ronald Turini, and has coached with such acclaimed pianists and pedagogues as Marylene Dosse, Lee Luvisi, and Jack Radunsky. She began her teaching career in 1977 at the University of Wisconsin-Stevens Point.

- 3. Technology—Michelle Sisler, Keys to Imagination "iPad Apps for Teachers". Michelle enjoys being creative in her teaching, making lessons interesting and fun for all students; her use of technology and creative teaching materials have gained her national recognition. Michelle has presented sessions at The National Conference on Keyboard Pedagogy, Music Teachers National Association conference, and various state conferences and local groups. She has written technology articles for Keyboard Companion, a series of technology articles in Clavier, and reviews in American Music Teacher. Michelle has co-authored Studio Makeover, Technology "Addition"®, Double Click Curriculum®, Are We There Yet? A Musical Journey Around the Globe®, Sebastian Sharp and the Case of the Missing Manuscript, Road Trip: America the Beautiful and more.
- 4. Christos Tsitsaros (Hal Leonard Publishing Company) "Musical and Technical Incentives for the Advancing Student". At the age of 13, Tsitsaros won first prize in the National Competition of the Conservatory of Athens. Upon graduating from high school, he moved to Poland where he studied at the Frédéric Chopin Academy of Warsaw. Two years later, as a result of winning the Gina Bachauer Institution Competition in Athens (1981), he continued his musical studies in Paris and graduated from the Ecole Normale de Musique de Paris, obtaining the Diplôme Supérieur d'Exécution with distinction. A scholarship from the A. G. Leventis Foundation enabled him to pursue further development at the School of Music of Indiana University in Bloomington, Indiana, where he received an Artist Diploma and a Master in Music degree (1989). Subsequently, he entered the School of Music of the University of Illinois where he attained a Doctor of Musical Arts in Piano Performance (1993). Christos Tsitsaros is currently Professor of Piano Pedagogy at the University of Illinois in Urbana-Champaign. He also serves as Piano Chair for the Illinois State Music Teachers Association.
- 5. Composition—Chris Goldston (FJH Music Company), "Yes, You Can Teach Composition". Christopher Goldston, Nationally Certified Teacher of Music, holds a Master of Music degree in piano performance and pedagogy from Northwestern University, and a Bachelor of Music degree in piano performance from the University of North Carolina-Greensboro. He teaches at Columbia College Chicago, and Sherwood Community Music School at Columbia College Chicago, and Chicago College of Performing Arts at Roosevelt University. In 1991, Mr. Goldston received the National Federation of Music Clubs Lynn Freeman Olson Composition Award for his first composition, Night Train. Since then he has written numerous pieces for piano, voice, and chamber ensemble, including his Thesis for Wind Quintet which won the 1993 MTNA Composition Contest for North Carolina. Mr. Goldston has compositions published by Alfred Publishing Company and is an exclusive author for the FJH Music Company. Mr. Goldston is the National Coordinator for the Music Teachers National Association Composition Competition.

Her piano teachers included James Ming and Clyde Duncan. Her organ studies were with Miriam Duncan, John Turnbull, Robert Scoggin and Russell Saunders, at the Eastman School of Music. She teaches piano in the Viroqua-Westby area and has taught hundreds of students, many of whom went on to study music in college. She presently serves as Director of Music/Organist at First Presbyterian Church, La Crosse.
- 8. "The Rite of Spring Revival: Bringing Century Old Score to Concert Stage" by Diana Shapiro and Stanislava Varshavski. Since 1998, when Stanislava Varshavski and Diana Shapiro started to play together, their duo became one of the most renowned contemporary piano duos. Varshavski and Shapiro were laureates of numerous prestigious national and international awards. Duo Varshavski-Shapiro made numerous recordings for Bavarian Radio, Radio 4 of Hong Kong, Wisconsin Public Radio and Israeli National Radio and TV. Moreover, number of duo's performances was broadcast live on radio throughout the world. Dr. Varshavski and Dr. Shapiro received DMA degrees from University of Wisconsin-Madison. Their principal teachers include legendary Israeli duo Alexander Tamir Bracha Eden and famous American pianists Victor Rosenbaum and Martha Fischer.

#### **Federal Trade Commission Investigation**

As most of you know, MTNA has been investigated by the Federal Trade Commission (FTC) because of our Code of Ethics. One portion of the code advised against seeking students who are already studying with another teacher. This was seen as being anti-trust and has now been removed from our Code of Ethics. As part of a settlement, all state and local associations have been asked to sign a compliance certification form no later than August 28, 2014 OR they need to file for an extension by the same date.

Each local association needs to take time and review information at the link below. A summary of everything that has happened with the investigation and settlement is included as well as many specific guidelines of what we can and can't do legally as MTNA members. If you have any further questions, contact your local association president, the state president or someone in the MTNA office. http://www.mtna.org/about-mtna/code-of-ethics/

#### Here are some topics that we cannot discuss as an association:

- Current prices or hourly rates;
- Current billing policies and procedures;
- What constitutes fair profit margins;
- Plans to increase or decrease prices or hourly rates;
- Agreements to allocate or divide territories or clients;
- Policies regarding vacation time and missed lessons;
- Terms and conditions of sales such as late charges, prompt payment discounts, credit terms;
- Recommendations to members to implement unlawful tying arrangements such as requiring students to purchase sheet music exclusively from the teacher;
- Salaries of music studio employees;
- Complaints about or problems presented by other competitors or suppliers;
- Encouraging others to take retaliatory actions against competitors or suppliers, such as a boycott against a supplier that decided to offer music instructions in competition with members; and
- Efforts to influence suppliers' prices.

#### Here are topics that we can discuss as an association:


- Data on past pricing levels that are compiled by the Affiliate to identify average prices; on the general economic trends in the profession;
- Discussions on how members can become more profitable by acquiring better knowledge of their costs:
- Discussing advances or problems in teaching methods and instruction;
- Education regarding various aspects of management and responding to student issues; and
- Discussions on improvements of services and educational methods.

Dear Wisconsin Music Teacher Association Members,

I would like to share with you my vision for WMTA and highlights from my background that have prepared me for the position of WMTA President-Elect. The first major thing I plan to do to move WMTA forward is increase the size of its membership. Many musicians within Wisconsin are teaching without the advantage of membership in a professional association. But, when teachers actively participate in WMTA and its local affiliates, they become better teachers. Conversely, when WMTA gains more members, the association leads and acts with a constituency comprised of greater breadth and depth in skills and experience. I see WMTA expanding to counties outside of its current local associations' geographic boundaries, and I see opportunities for attracting and developing music majors and recent college graduates. Also, I see local leadership empowered by state mentorship to welcome and recruit non-member teachers in their regions.

With growth comes a need to focus vision. The second major thing I plan to do is develop a stronger sense of direction and purpose for WMTA. Central to this goal will be the creation of a mission statement. A mission statement will provide a positive and focused framework for the work we do in WMTA. The mission statement will govern and target the types of projects we bring forward and will speak to prioritization and process.

Since graduating with a DMA at UW-Madison in 2002, I have been teaching at Lakeland College. During this time I have remained active professionally as a musician and teacher outside of my role as a college professor, and it has been my habit to serve my profession and reach out to music teachers within and without WMTA. I served two years in WMTA as the MTNA Competitions Chair, and six years on the Administrative Council. For Michibago Music Teachers Association (MMTA), I served as vice president, chair of the Growth and Development Committee, chair and co-chair of numerous festivals, and most recently for the past four years president of the association. During my tenure as president, MMTA started a website and a Facebook page, adopted a logo, amended/updated its constitution and bylaws, attained 501(c)3 non-profit status, established and maintained a flourishing awards fund, and developed an annual budget.

My pre-college students have been prize winners in numerous competitions, including first place in the Fox Valley Concerto Competition, first place in the Polish Fest Chopin Piano Competition, first place in the WMTA Badger Keyboard Competition, and first place in the WMTA High School Virtuoso Competition. Notable performances of my own include soloing with the Lakeshore Wind Ensemble (Liszt Piano Concerto No. 1) and the Sheboygan Symphony Orchestra (Beethoven Choral Fantasy) and a lecture recital with cellist Matt Turner and pianist Drea Wagner entitled, "History of Improvisation in Western Classical Music: Bach to Schoenberg and Beyond." # **Nicholas Phillips**



Dear Wisconsin Music Teacher Association Members.

When first asked if I would consider being nominated for President of WMTA, my initial reaction was: "Why me? No way! I'm too busy! Besides, I'm sure there are many interested people that would do a much better job than me!" By the time that conversation was over, though, I had promised to think seriously about it. After some reflection, I felt confident I could make a positive contribution to WMTA through this position, so I accepted the nomination and am excited about the possibility of serving the group in this capacity, should I be elected.

I have been a member of WMTA since moving to Wisconsin in 2007, and have served on the Administrative Council since then; first as Chair of Composition Competitions and now solely as Chair of Composer Commissioning. I have also been active at the State Conferences, having attended each one, given two lecture-recitals and one presentation, participated in panel discussions, and premiered four piano pieces that

were written for WMTA. I've enjoyed meeting many teachers from around the state, and have made many new friends in the process. If elected President, I would continue to work with the Executive Board and Administrative Council on programs and issues important to WMTA members, and to represent Wisconsin nationally at MTNA events.

#### **Biography**

Nicholas Phillips is Associate Professor of Piano at the University of Wisconsin-Eau Claire. He is extremely active as a soloist and collaborative artist, having performed across the United States. His most recent season included solo recitals in New York, Chicago, Baltimore, Alabama, Ohio, Michigan, Montana, Rhode Island, Texas, and Wisconsin. Recent international appearances include a solo recital in Korea sponsored by the U.S. Embassy, and a solo recital in Buenos Aires, Argentina.

Described by the New York Times as an "able and persuasive advocate" and a "talented, entrepreneurial pianist," his playing has been praised for its "bejeweled accuracy" (Fanfare) and as "razor-sharp yet wonderfully spirited" (American Records Guide). In 2011 he released two CDs on Albany Records: Portals and Passages, featuring piano music by American composer Ethan Wickman, and Boris Papandopulo: Piano Music, featuring solo piano music by the famous 20th-century Croatian composer. His most recent CD project, American Vernacular: New Music for Solo Piano (New Focus Recordings), features works written for him by 10 American composers.

Phillips has given lecture-recitals and presentations at a number of international, national, and state conferences, including: the College Music Society International Conferences in Zagreb (2009), Seoul (2011), and Buenos Aires (2013), the Minnesota (2010) and Wisconsin (2008, 2009, 2011) Music Teachers Association State Conferences, and the Seventh Biennial Conference on Music in Nineteenth-Century Britain in Bristol, UK (2009). He has also presented to local WMTA chapters, is an active adjudicator around the state, and has submitted his application for MTNA certification. Phillips holds degrees from the University of Missouri-Kansas City Conservatory of Music (DMA), Indiana University (MM), and the University of Nebraska-Lincoln (BM). #### **2015 Badger Keyboard Competition**

All sites will hopefully be on Saturday, May 16<sup>th</sup>, please watch the newsletters for confirmation of this date. Northwest region will be at UW- Eau Claire, this site is definite! Northeast will be at UW-Oshkosh (still working out details, so watch for confirmation), Southern should be at UW-Whitewater (again watch for confirmation).

As we are preparing students for competitions, here are a few ideas for planning and some thoughts to keep in mind:

- 1. Choose competitions which fit with your pedagogical goals for students rather than setting goals based on competitions. As teachers we want to always be aiding musicians on a journey which we hope will last them a lifetime. This means our goals should be based on long-term development (long term meaning YEARS rather than MONTHS). Our curriculum should be helping students develop the skills needed to learn WITHOUT a teacher music reading, knowledge of style, score analysis, self-evaluation. With our pedagogical purpose in mind we will at times decide that a student does not need to compete, or that a competition will not aid in teaching the skills we are trying to develop in the student.
- 2. Teach your students to love music, not winning competitions. Ideally every student should love playing their instrument because they love the experience of creating sound, shaping the ideas as they play and expressing their unique thoughts. Winning competitions is fun, but winning only lasts a short while. Getting to make music can be enjoyed for a lifetime.
- 3. Use competitions to expose students to other musicians (also could be phrased as teach them that going to the winners' recital helps us appreciate our colleagues). Many students hear only themselves and then a few times a year they hear their studio mates. Competitions can be a wonderful way for a student to see what other students his/her age have accomplished.
- 4. Teach parents to encourage their children whether or not they win. If parents are focused solely on winning, it is really difficult to encourage students to play for the love of playing. Many times our role as teacher is to teach the parents how to help their child perform well. We need to always show an example of positive comments and praise mixed with helpful criticism.
- 5. Teach that getting to participate in competitions is a wonderful opportunity. They should have a positive attitude throughout the whole journey. Getting to perform at any competition is an accomplishment. It means that they have already put forth a substantial effort to learn their pieces. Performing these pieces is an opportunity to share something special for a judge who wants to hear lovely performances.
- 6. Be proud of your students who compete and make sure you share their achievements in your local newspaper, studio newsletters, and with their school administrators. They deserve recognition for their hard work no matter what the outcome.

Best wishes to all teachers as you plan out your coming year. Hopefully I will see some of you throughout the process of District Auditions and the Badger Competition. Most importantly, enjoy making music with all your students with or without competitions.

#### WMTA District Auditions News – Summer 2014

If you're in a hurry, glance at the underlined text to get a glimpse of each subject I'm addressing in this report.

- For 2015, all districts will be using the "Ovations" online registration program. There will be an informative session about using Ovations at the fall WMTA conference held in Stevens Point.
- District Auditions <u>dates for spring 2015</u> should be confirmed and available by the time the fall conference rolls around in October 2014.
- There will be a <u>Judging Information session</u> for WMTA events presented at the fall conference. This session is for both new judges and seasoned judges who would like new ideas. This will also be helpful for teachers who are interested in what judges might be looking for while hearing student performances. The session will include suggestions for writing specific and effective comments that support the rating given, creating a positive learning experience for every student and a summary about specific entry "tracks" and requirements for WMTA events.
- I continue to keep a <u>file of comments received about judges</u> after WMTA events updated each summer. This file is available to district chairs to assist in setting up judges for their next year's auditions.
- I keep a <u>file of judge's contact information</u> for anyone who has expressed an interest in being a judge or has already been judging WMTA events. *IF YOU ARE A JUDGE* and want to update or verify the information that I have on file, feel free to email me anytime. tschoo@centurytel.net
- Hello and thank you to <u>Elena Petrova</u>, who will be taking over for Suzanne Fauser as the <u>Milwau-kee/Waukesha district chair</u>. Many thanks to Suzanne for her many hours of dedication to the new "Ovations" online project! And welcome Elena!
- Watch for the <u>new WMTA website</u> that will be coming this fall there will be a whole section of the website dedicated to "Student Events" where you will find everything you need to know about district auditions and other WMTA student performance opportunities.
- A reminder about <u>auditions repertoire</u>: please make sure the pieces you choose for students have <u>at least 16 measures!</u> This was a widespread issue throughout the state this year. It's easy to miss on occasion, but it's also a very simple rule. Please make a point to think about that when selecting repertoire next season.
- For students that enter state track auditions in piano and another area (such as piano and voice, or piano and violin), there is a <u>rule change regarding theory test requirements</u>. Students may take two theory tests to accommodate the different minimum levels that are required for each area. In the past, students in this situation were required to take the test based on their level for piano only (meaning the student had to take the harder exam even if their instrument or voice requirement was an easier test level.) This may sound confusing, but for those teachers who have had students in this situation, you are aware of how this works. #### 2014 Badger Non-Keyboard Report

Badger Non-Keyboard Competition was held at UW-Stevens Point again this year, with Mary Hofer as site chair. We used 3 rooms; it was requested we not use the choir room in the future due to noise in the air ducts. Flutes were in this room:

We are again, down in numbers of students, but up in teachers, due to some new ones. The judges were very good; wrote a lot & were very encouraging to our students, so I think it was a very valuable experience for everyone. And I know, personally, the students really look forward to this competition. We lost 2 active teachers this year; 1 moved out of state, another had surgery & could not have students participate. They have both sent numerous students to Badger NK, so our participation numbers were down just from them.

Having the judging forms on-line for each teacher to print & fill out their own worked very well. There was some confusion from districts where teachers did not get the correct summery form to fill out, and did not follow the directions that were on that form. There are, again, questions being raised; but we will be revising the handbook, and that should solve the problems.

We again had 1 student working as door monitor for the vocal room; string teachers run their own room and have no problems doing this. Jenny Burton did all the recording, and David Burman(my son), with Opala Bilhorn, registered all the students and took their pictures. <u>I would suggest</u> that when we are using the college campuses, why not ask for music students to help door monitor? It would help involve future possible members, and teach the students about our organization, also.

Competition was from 8:00AM – 1:30PM. Snacks and beverages were provided by the participating teachers, which was plenty. There were 3 judges; 1 string, 1 vocal and 1 guitar. It was suggested that we put the 1 guitar in with the strings, which was done at district. But I hesitate to compare them at the state level. I prefer keeping them separate; it also gives students more chances for awards.

We had one major 'glitch': the flute judge never showed up. That ended up being a major miscommunication between myself & the judge. We have cleared that up. So the 2 flute teachers in attendance (Sue Christian & Norma Kretzschmar, both from the same district!) listened & critiqued the 3 students. They went over the performances with a 'fine tooth comb' & awarded all 3 students accordingly. Everyone was pleased with the way it worked out. The teachers scored each piece, and the students were only 1 point apart for awards. Thus = some very fine performances and teaching!

Overall this year's Badger NK was a great experience for students and teachers. I'm looking forward to another great year in 2013. All teachers were most helpful and great to work with.





Arlyss Troge has accepted the position as VP Membership, Drea Wagner has accepted as Badger Collegiate and Bethany Hartlaub has accepted the position as Arts Awareness.
- Immediate Past President Gail Heywood, NCTM No Report.
- 1st VP-Conference Gail Heywood, NCTM This year's Annual Conference will be on October 24th-25th. Everything is on track and we are looking forward to several exciting, new and updated events. There will be a recital on Friday night by Tammie Walker that was omitted from the brochure. An important change from past years, the lunch fees for Local Association Meetings and District Chair meetings will be collected along with registration, not during conference. Conference dates for 2015 will be October 23th and 24th.
- 2nd VP-Membership Arlyss Troge As the exiting VP of Membership, Emily Luker reported that WMTA had 472 members as of the last day of March 2014. We have 215 renewing members as of May 28. - Badger Collegiate Competition Drea Wagner, NCTM Badger Collegiate Performance Competition was held on May 17<sup>th</sup>, 2014 in UW-Stevens Point. Nine students from two colleges enrolled and six of these students attended and competed. This competition was held at the same time and place as the Badger Keyboard Competition which saved on the overall facility costs and labor. The council agreed that it was a worthwhile event, but the time may need to be adjusted to better suit the schedules of the students and teachers who participate. The council discussed the possibility of piggybacking this event with the district events in March so it has better timing for the students.
- Badger Instrumental/Vocal Competition Nancy Burman, NCTM –Not Present. The competition is down to less than half of what it has been the past, but is still bringing in new teachers and is well appreciated by those who attend. The judges were very good and wrote a lot of encouraging notes.

All submissions should be submitted 2 to 4 weeks in advance and must be received by the 15th day of the month prior to issue date or they will not be included and are subject to space availability. All August newsletter submissions must be received by the 1st of July.

To propose information, please email the central office with potential text and pictures. All text should be concise and edited for content, spelling and grammar. Photos should be clear, high resolution and ready for publication. All content is subject to approval before it can be included.
