"CELEBRATING COMPOSITION with Dr. Kevin Olson" is an opportunity for teachers and students to pull the curtain back on the process of composition, and to engage with and learn the tools and strategies for creative composition.

While all of the details are still being fine tuned and subject to some change, a rough outline of his time with us is as follows:

Friday, September 15, 2023 -

- 4:00-6:00 Teacher day focused on composition, all of its variables, and methods for teaching the processes
- 6:00-7:00 Catered meal for all participants, a wonderful community opportunity and chance to engage with WMTA members
- 7:00 Presentation of newly commissioned pieces honoring Deanna, performed by Dr. Olson

Saturday, September 16, 2023

- 10:00 noon Student day, workshops on composition and performance of Kevin Olson works by students.
- 12:00 1:00 lunch
- 1:00 3:00 More student workshops, Q/A regarding the process of composition.

This will be an opportunity for students to play their own compositions, and get valuable feedback and coaching. This could also be an opportunity for students to perform Kevin Olson's pieces, and to quiz the composer on why he chose particular devices in the piece. We envision this day as being very interactive with students, helping them to understand the creative energies and the process which to some may be a bit of a mystery.

Dr. Kevin Olson is a very active pianist and composer and has written pieces that our students love to play, and we as teachers love to work with. He directs the piano program at Utah State University, and we are thrilled to have him working with us. We invite all WMTA members to take part in these workshops, and to celebrate Deanna Roen in the premier presentation of these newly composed pieces. WMTA District Audition News

Conference 2022 was amazing. I not only loved the BEAUTIFUL trip to Superior with all the amazing fall colors but I also loved seeing so many WMTA Teachers again!

A LOT of work has been done to update the www.wisconsinmusicteachers.com website. There are more links available to find what you are looking for better. Please visit the website to see all the updates. However, I do want to point out the incredible flow charts that are now available. Check them out!

The Spring 2023 District Auditions will be held IN PERSON. There will not be a Virtual audition process offered. The administration of theory exams will vary from District to District so be sure to read the emails from your amazing District Chair leaders! Some theory exams will be administered in person while others will be online. Each student should plan to take the theory exam in the same district as their performance.

For all your questions, please reach out to your local District Chairs. They are prepared to help you succeed in the upcoming auditions. They are your first step to obtaining information regarding your district's auditions.

As a reminder, we no longer have requirements to use certain "historical periods" across the board. Students auditioning to compete at State (Badger) must choose one piece from the Baroque/Classical list of composers. Please refer to the WMTA website for specific rules. Our New Database is called "Cadence". More info will be coming from your District Chairs...please watch for their emails and reach out to them if you have not received an email this year.

You will not be choosing your pieces from a "database". You will have a place on the application to write in the title of the pieces for your students. It is very important that you write in the name as it appears on the music that will be used to avoid disqualification. There is a rule in place regarding Downloaded music. WMTA has requirements for using downloaded music. While we still want to really encourage teachers/students to PURCHASE printed music for students to use in auditions, we also want to support LEGALLY downloaded music that follows the US Copyright Laws.



District Auditions Continued:

Therefore, we will be having two items in place:

- 1. Our rules state that by entering the auditions/competitions the students agree that they are following the copyright laws. (We have provided a link to a one page summary of the copyright laws.)

 AND
- 2. The student/parents will fill out and sign the <u>Copyright Representation and Indemnification</u>
 <u>Agreement Form</u> stating that the music they are using does in fact follow the US Copyright laws. This statement must be printed and present with the music when the music is given to the judge at the competition. There will be no exceptions to this because WMTA cannot be liable for a Copyright infringement by a teacher/student. If you have questions about any specific music please email me at: Sandra.statz2@gmail.com

Aural Theory testing: As a reminder, ALL students will receive ONLY TWO hearings of the Aural Theory questions during the Audition Theory testing. This has always been the rule, therefore, we want to emphasize for our newer teachers that this may take some training on your part. FYI, intervals are played melodically going up, then down, then together...that's one hearing. If you do have questions about how the testing is done, contact your local District Chairs.

All applications must be completed by the Application Due Date for YOUR home district. There will be NO applications accepted late! Please also have your application fees turned in by your district's due date. If you do have a student entering out of district you MUST first contact YOUR HOME District Chair so they can help facilitate any post auditions awards. Then, get permission from the out of district District Chairperson as soon as possible but absolutely prior to the application due date and follow all deadlines for that district for that student. Theory Study guides: Both the Comprehensive Study Sheet AND individual study sheets are available on the WMTA website for your use/choice.

If you missed the Oct 15 membership renewal deadline and are NOT a new teacher, to enter students in the 2023 auditions you must submit your \$150 late fee, made out to WMTA, to me. Contact me for my address. New members are allowed to enter students for auditions without paying the late fee.

WMTA State Keyboard Competition 2023

Whereas the WMTA Regional Keyboard Competitions (formerly Badger) designate divisional/grade level winners in each of our 3 Regions, this competition allows those winners to compete with each other, and determine a true state winner at each division/grade level.

If the Winner of any grade level is not available or does not want to advance, the opportunity will be given to the Runner Up at the grade level, in that Region. If neither will participate, there is a default at that division/grade level, in that Region. This will look quite different from our District events, and our Regional Competitions:

ELIGIBILITY: WINNING participant in each division, grades 7-12, at each of the Regional Keyboard Competitions: South, North East, North West

TOTAL NUMBER OF PARTICIPANTS: 18 (6 divisions, 3 regions)

WHEN: Saturday, May 20, 2023

WHERE: UW - Stevens Point

REGISTRATION FEE: \$40, payable to WMTA, sent to Mary Anne Olvera, 664 Louise Lane, Hudson, WI 54016

REGISTRATION DEADLINE: Tuesday, May 16 This will look quite different from our District events, and our Regional Competitions:

ON COMPETITION DAY:

All performances will be held in the Recital Hall with a defined schedule. Three judges will listen to all entrants at each division at the same time and Recital Hall performances will be open to the general public, with admission fees. Admission fees are: Adults (\$10), Non-performing students (\$5), and for Age 5 and under (free). A 15-minute deliberation time immediately follows the last entrant at each division/grade level, and all 3 judges collaborate to determine the winner at that division.

All Winners for all divisions/grade levels (there will be no Runner Up placements) will be announced at



Awards Presentation at the end of the day.

Points = 15 for Winner plus Winners Trophy, 10 for participants, and all receive Certificates

OTHER IMPORTANT ITEMS:

In the interest of equity, all performances will be held to a strict 15 minute time limit. There will be no option to ask for a time extension. To maintain the determined schedule, judges will cut students off if they exceed time limits. It will be incumbent on teachers to choose repertoire that is in line with these requirements, and/or prepare students to be cut off if their program exceeds 15 min.

The turnaround time between Regional Competitions and State Keyboard Competition is very short. It may be best practice to tell students to consider whether they would want to advance to State, if they had the opportunity, right in the beginning of preparations.

FAQ'S ABOUT THE NEW COMPETITION

Will this be like a large recital, where we get to see all the finalists?

Yes, this competition is unlike any of the other events. All performances are on the recital hall stage. Admission (day passes) will be charged @ \$10 adult, \$5 non performing student, under 5 yrs, free.

Who is eligible to participate?

This competition is open to the grade 7-12 Regional winners @ S, NE, NW, totaling 18 participants

• What happens if the Regional Winner doesn't want to/can't participate?

If this occurs at any region, the opportunity to perform falls to the Runner-Up at that grade level. If the Runner-Up can't participate, or there was no designated Runner Up, there is a default at the grade level in that Region.



• Will there be only one judge?

There will be 3 judges adjudicating the same event at the same time for all grade levels. After the last grade level winner has performed, there is a 15 min. deliberation time built in for the judges to determine that grade level winner.

• What does the schedule look like?

The day's schedule is already determined, with a start time at 8:00, 15 min. for each participant, 15 deliberations, then turnover to the next grade level. Each Region will be rotated for a starting position in the next grade level. This continues throughout the day, with an awards ceremony at 3:45.

Are students and their families required to stay for the whole day?

Students are not required to stay for the whole day, but all are strongly encouraged to attend as many performances as they can. These are students playing at the peak of their ability, and this is not only highly motivating for students, but highly instructive.

What will the judges be listening for at this level of competition?

Every student performing has already distinguished themselves as winners in their Regional competitions. They are called to demonstrate a higher degree of mastery of this repertoire. They need to come to this with fresh ears.

Students will be evaluated on the preparedness and mastery of their pieces, not the difficulty and not the length.

Aside from precise notes and rhythms, some examples of what judges listen for are beautiful phrasing and beautiful musical statements, expressive creative dynamics, beautiful tone color, rubato well performed where needed, balanced and creative voicing, artful articulation as noted in the score.

This is a competition in search of the masterful musician, the student that understands that flawless technique is not the end game, but a tool to deliver beautiful music making.

• Should teachers make cuts to the score if their music exceeds 15 minutes?

No, the adjudicator will respectfully cut the student off, but teachers can prep students for a cut-off if their program exceeds 15 minutes.



• If students are cut off, can you still win if the judges have not heard all three pieces in their entirety?

Yes, judges can certainly determine a winner even though all repertoire may not have been heard to completion. A winning performance is not dependent on the length of the piece, nor its difficulty. Students are evaluated on the preparedness and mastery of their pieces, not the difficulty and not the length.

• It seems like 15 min. is too short, especially for some pieces. Why can't students prepare programs that go over 15 min.?

The 15 minutes time limit is in place to create equity for every single student that is playing. It is not meant to discourage students from learning larger repertoire, especially those students preparing college entrance auditions. But if a student's program does exceed 15 minutes, simply prepare them for the probability that they will be respectfully cut off. (*And parents and students are reminded that most college entrance auditions are capped at 10 min.*)

• If the Winner or the Runner Up do not perform for that grade, then is the Winner from the Regionals still the Winner of the state?

The grade level winner at Regionals was never the winner of the state. They were the winner of that region of the state only, either NE, NW, or S, only that third. That is what this new True State competition is all about - the opportunity for regional winners at grade level to meet the other regional winners and compete, thereby determining one true winner at grade level in the state. The Regional/Badger competitions did not do this. And that's what makes this exciting!

Obituaries

It is with great sadness that I announce the passing away of Marilyn White Lowe, the author of the Music Moves for Piano series that I use in the Reuss Music Studio. Some of you might remember her from the piano teacher workshop I organized here in Waukesha where she asked for some students to demonstrate with to show how Music Learning Theory and Music Moves for Piano worked together and several of you volunteered!

I have benefitted in so many ways by knowing Marilyn. She was always available to explain, give encouragement, provide demonstrations, and just be a kind human being. The courses I took with her and conversations will be memories I cherish. I am a better musician and teacher because of her and will miss her very much!



She was beloved by many members and a regular fixture at teacher's conventions, both in the US and internationally. She studied piano at Indiana University with Pressler. She spent a summer in France studying with Nadia Boulanger and Poulenc, and almost completed a doctorate in music theory.

Nonetheless, she was unsatisfied with her teaching. While her students read music well and played nicely, they were incapable of playing by ear and improvising. In the 90s she attended Dr. Edwin Gordon's lectures on musical aptitude and audiation. It was exactly what she had been searching for.

The result was "Music Moves for piano." A massive piano curriculum totaling several thousand pages. In a vast departure from other methods, it placed audiation (the ability to "think" music) at the center of the learning experience.

In the pedagogy community, Marilyn was a font of information. Always eager to answer questions, educate, send musical gifts in the mail, and offer an encouraging word. She loved going to the theater and concerts and had dozens of children, grandchildren, and great grandchildren.

Up until her illness this spring, she traveled extensively. She had friends all over the US and the world. She was kind, generous, adventurous, and had a matter-of-fact Midwestern way about her. She will be missed.
